Marian College student Scott Richter has decided on his career goal: it's to become Marian College professor Scott Richter.

The accounting and economics & finance major from Van Dyne plans to get a Master of Business Administration degree and a doctorate in finance, and then return to Marian to teach beginning-level accounting and finance courses.

Scott is already making progress toward his goal. He has gotten teaching experience as a tutor of students in Marian's Business Administration Division and in Marian's Center for Academic Support and Excellence, as well as in the math lab. He has gained

hands-on experience as an accounting intern for Marian's Common Grounds Coffee House and while doing income tax preparation work, most recently for a Fond du Lac-area CPA firm.

His other Marian activities include working for Marian's Office of Institutional Research, serving as vice president of the student chapter of the Society of Human Resource Management and treasurer of Marian's Business Club, and serving as the student representative for three college committees.

## Edgewood business major appreciates strong preparation for her future career

Dustin Wilfling can accomplish just about anything she sets her mind to—but she finds it impossible to pinpoint the exact reason why she loves

Edgewood College. "It's the whole experience. I am proud of the person I have become here."

Edgewood College was the first school Dustin visited. The rest, as they say, is history. "The minute I was on the campus, I fell in love with it," Dustin remembers. "All the way home, I sat in the backseat thinking, 'This is where I will go to school.'"

Fortunately, Dustin's experience has exceeded even her high hopes. "The professors are so passionate about what they teach, and

that makes me passionate about the subject," she explains, singling out two of her business professors, Elaine Beaubien and Al Talarczyk, for special praise.

Dustin is grateful that a financial aid package including a Wisconsin Tuition Grant has enabled her to focus on preparing for her future career. "I came knowing I wanted to be a business major. Later I added concentrations in management and marketing."

Dustin is so enthusiastic about Edgewood College that she

Not content to limit his service to the campus community alone, he also is the 4-H volunteer treasurer for Winnebago County.

“Marian has helped me grow,” says Richter, who this month will be the first person in his family to graduate from college. “When I got here, I was shy and much more reserved, very academic-focused, didn’t participate in anything. I’ve since opened up a bit more, respect others’ opinions more; I enjoy looking at different viewpoints.”

Richter’s interest in accounting dates back to high school in Oshkosh, where he “got to work ahead in accounting. I like being able to go out on my own and work ahead, and I’ve had some of that in the Marian accounting program.”

He’s interested particularly in teaching basic accounting, since “I’ve heard that there is

a shortage of professors in accounting and particularly in finance. I relate to business; I like seeing the bigger picture.”

Richter says he is particularly grateful for the financial aid package he received from Marian College, which included a Wisconsin Tuition Grant. He deems the financial help crucial to getting the higher education he wanted. “If the grant hadn’t been there, I don’t think I could have done it.”

To that end, Richter was one of Marian’s representatives at WAICU Students’ Day in Madison, during which resident private college students visited their state legislators at the Capitol and asked them to support WTG funding.

“It’s nice to see that there are some people in Wisconsin who see this as important,” he says.
